In Memoriam - Allan Spencer Dyer



Allan Spencer Dyer of Austin died peacefully on Monday, October 10, 2005. Allan was born in Austin on September 12, 1941.

He was preceded in death by his parents, Ora and Spence Dyer also of Austin. Allan is survived by his sister, Kaye Dyer Dunbar and her husband Howard of Houston. He also is survived by nephews Brandon Dunbar and

Christopher and wife Nancy Dunbar and great niece and nephew Madison and Spencer Dunbar of Houston; cousins Ed Dyer and Becky of San Antonio and Darlene and Richard Whittington of North Little Rock, Arkansas.

As a young man, Allan was active at University Baptist Church. He achieved the Eagle Scout Award as well as recognition as a National Merit Scholar. His love of foreign languages was a driving force in acquiring his Masters Degree from the University of Texas at Austin in 1965. Allan taught foreign languages as a college professor, beginning at Odessa, Texas, in the 1960's, and concluded his teaching

career in 2001 at Baylor University in Waco. On the Baylor campus, he was showered by attention as the sponsor for Pi Beta Phi. In addition to his vast knowledge of languages, he was an accomplished cook and always enjoyed making delicious meals, often topped off with a cup of tea. Allan was an avid reader and collector of books as well as his beloved teapots. He was comforted by his dogs and cared deeply for them.



The judges will choose the winners of these titles from the total pool of contestants.
